

## INVESTMENT OBJECTIVE

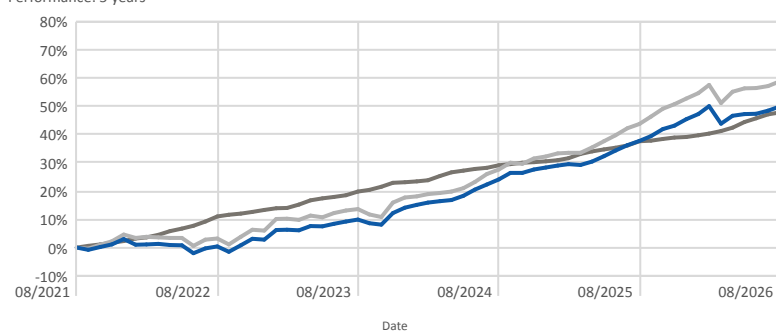
The objective of this portfolio is to provide the investor with a high level of income combined with stable medium to long term real capital.

## INVESTMENT POLICY

The S-BRO FR Defensive Fund of Funds is a conservative managed fund of funds. The objective of this portfolio is to provide the investor with a high level of income combined with stable medium to long term real capital growth and will seek to follow an investment policy which will reflect a spread of investments aiming at income and capital growth normally associated with the investment structure of a conservative retirement fund. It will invest in a broad range of participatory interests and other forms of participation in collective investment schemes or similar schemes. To provide a limited level of capital growth, the portfolio's equity exposure may be as high as 40% of the portfolio's net asset value.

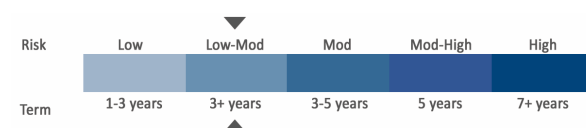

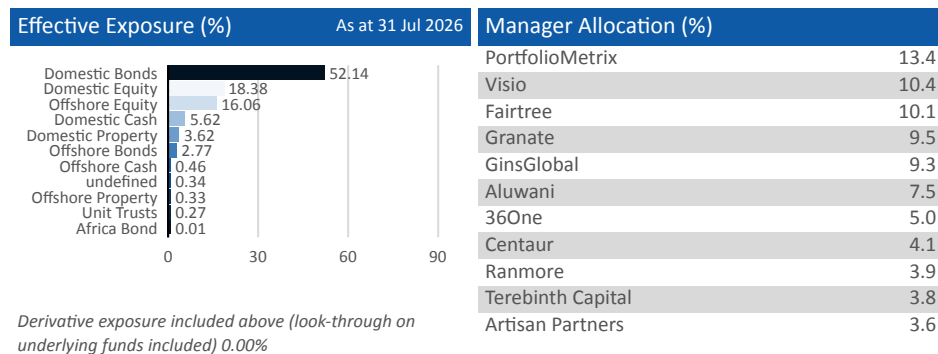
### Low - Moderate Risk
