The portfolio may invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes as the Act may allow. The portfolio may from time to time invest in listed and unlisted financial instruments.

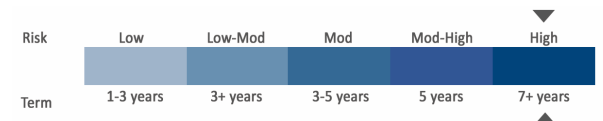

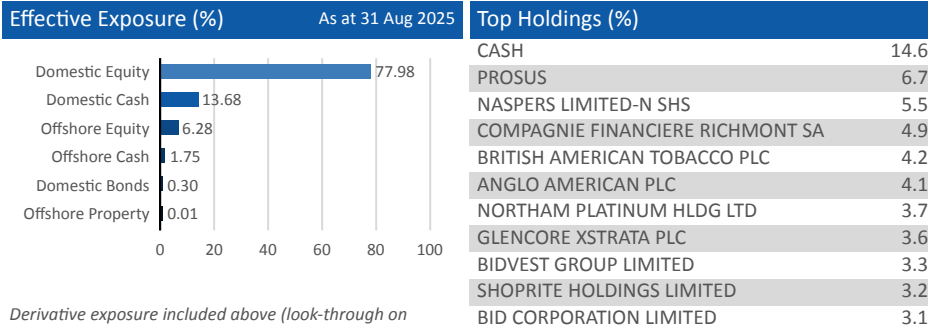
High Risk
